Natural England Wildlife Licence Fees Consultation: class & individual licences, proposed fees and exemptions

- We are inviting views about the way we fund the wildlife licence service in the future to ensure value for money for licence-applicants and the taxpayer. We are interested in your responses to help ensure proposed fees and exemptions are reasonable.
- You need a wildlife licence from Natural England if you plan to disturb or remove wildlife or damage habitats.
- We are proposing a number of exemptions to proposed charges. We are not proposing to charge for licences where the aim is the prevention of serious damage to property (such as crops or fisheries), the prevention of spread of disease, householder development projects, and conservation project delivery or conservation or research. Please see table 3.
- The introduction of charges is one part of reforms to the service that should provide a better customer service and improvements for wildlife.
- Charging won't change the criteria on which wildlife licences are assessed or issued. Natural England will maintain its impartiality in judging licence applications by following robust processes subject to routine scrutiny.

This document has all the proposed fees and exemptions for class licences and individual licences. General licences will not be charged for.

- 1. **Table 1: Class licences** are those where the applicant is registered to use the licence, the licence has standard conditions and is available for reference on the Natural England web pages. The applicant has to provide an annual report to remain registered.
- 2. **Table 2: Individual licences** are issued to a named applicant for a project and have bespoke conditions. A report has to be sent to Natural England, usually at the completion of the project.
